- 1) This contract, once paid in full, reserves one breeding during the 2018 season for the above mentioned mare to Racy Casanova, which will include a live foal guarantee a foal that is able to stand and nurse (or be hand fed), for a period of 72 hours.
- 2) For an Embryo Transfer a separate contract must be submitted, and Stallion fee paid, for each embryo.

All fees, charges, and deposits due to the Stallion Manager, Kaitlyn Keller shall be paid before the semen is shipped, picked up, or before the mare is bred on farm.

2018 STUD FEE \$_1250 (including first overnight shipment. Same day shipping additional charges apply) Booking fee of \$250 must accompany this contract to reserve a breeding to aforementioned mare.

3) Mare owner fees for on Farm Mares at Iowa State University. (Subject to Change) Mare care at ISU is \$22/day. For Dry, Wet, or mares with foals.

A mare breeding management fee will be \$300 per mare, per cycle. This will include estrous detection, artificial insemination and general management of the broodmare. Any necessary uterine cultures, uterine biopsies or uterine treatment will be billed to the owner of the mare(s) at cost for each procedure. Mare owners are responsible for paying this to ISU. Stallion owners and manager are not responsible for any Mare fees at Iowa State University.

Semen pick up or shipped semen payable to Stallion Manager PRIOR to pick up.

No SEMEN will be shipped or picked up without payment in full. (Credit cards accepted)

\$150 per Cooled Semen Pick Up (mare owner or representative will travel to ISU to pick up the collection for insemination off-site)

\$275 overnight shipping

\$500 counter to counter, same day shipping

Shipping to Canada additional fees may apply. Call for information and quote

4) Iowa State and the Stallion Manager will make every attempt to satisfy all breeding commitments. Racy Casanova has excellent semen; it is in great demand on collections days during the breeding season. Therefore, the mare owner or veterinarian must give 24 HOUR NOTICE when semen is needed. Mare owner or Veterinarian MUST CALL BY 8:30 AM ON COLLECTION DAY TO CONFIRM SHIPMENT Priority is given to mares at ISU and then priority is assigned by order of notice given.

5)The mare shall be in sound breeding condition, free from infectious and/or contagious diseases, and current on all vaccinations and deworming, prior to breeding. A current negative Coggins test and health and immunization records shall accompany the mare if managed at ISU. ISU reserves the right to refuse any mare presented in unsatisfactory condition. ALL MARE CARE IS RESPONSIBITY OF MARE OWNER PAYABLE TO ISU, DUE PRIOR TO MARE LEAVING ISU.

Collection days are Monday, Wednesday, and Friday. February 1st - June 15th 2018

- 6) ISU will meet or exceed the standard of care for all mares/foals on premises. ISU will examine on site mares for reproductive and overall health and will administer medical care and farrier service as deemed necessary. The mare owner agrees to pay for needed medical treatments/farrier services necessary to provide the standard of care by ISU. Other than as provided in this agreement, ISU will not be liable in any way for the mare failing to conceive, loss of pregnancy, injury, illness, or death of the mare or foal in their care for the purpose of fulfilling this contract. Insurance is the responsibility of the mare owner, and ISU can assist with insurance forms for coverage on a mare, foal or foal in utero.
- 7) ISU will collect, evaluate, and inseminate on farm or ship an industry standard dose of live semen in viable condition and will provide analysis when shipped. ISU cannot control circumstances after the semen has left their possession, and ISU assumes no responsibility and makes no guarantee of quality or delivery via Fedex, UPS or counter to counter airline transit.
- 8) The mare shall be examined by ultrasound to determine pregnancy between 14 and 18 days post ovulation. Pregnancy status shall be reported at that time to STALLION MANAGER, should the mare check open, arrangements can be made for additional shipments of semen and an additional payment of collection/shipping shall be assessed.
- 9) If ISU is unable to service the mare at any time, for any reason including death, illness, accident, or change of ownership, this contract will become void.
- 10) This contract is non transferable and the Mare Owner may not assign any rights or delegate any duties without the written consent of the Stallion Manager.
- 11) Pregnancy status must be reported to Stallion Manager, by August 1 of the breeding year. Failure to provide pregnancy status updates means the mare WILL NOT be listed on the Stallion Breeding Report. If an amendment must be made to the stallion report after submission to AQHA, in order to accommodate the Mare Owner, the Mare Owner is responsible for the late filing fee as well as an addition of a Mare to the report fee (\$50) and the fee shall be paid to Stallion Manager before a breeder's certificate will be provided.
- 12) Any unpaid fees, including but not limited to the stud fee, on-farm breeding charges, or shipping fees will be charged interest at the rate of 1.5% per month, or the highest legal rate, on all balances unpaid for thirty (30) days. Breeders certificates will not be released until all related payments have been received.
- 13) In the event a dispute arises between the above mentioned parties from this contract, it shall be submitted to a court of competent jurisdiction, to arbitration, to mediation, or to any combination thereof for resolution. The prevailing party shall be entitled to all cost of such proceedings, including attorney fees. This contract shall be construed according to the laws of Coffey County, in the State of Kansas, to the exclusion of the laws of any other jurisdiction.

- ✓ ALL SHIPPING CONTAINERS ARE REQUIRED TO BE RETURNED WITHIN 5 BUSINESS DAYS
- ✓ Please notify us 14-18 days post breeding if your mare is in Foal or not. We need notified for our records and stallion reports. This is mare owner's responsibility to report this information.
- ✓ We will return a copy of your signed breeding contract with a receipt of services as soon as possible for your records. And send paid invoices for services as well.

During the Breeding Season Shipping Days are Monday, Wednesday, and Friday. Earlier than February 1st please call for availability. Normal shipping season is set for February 1-June 15th Please Call at least 24 Hours ahead to Order Semen if Possible, YOU (or your Veterinarian) MUST CONFIRM YOUR SHIPMENT NEED BY 8:30AM ON SHIPPING DAY!
